1、Yeah, their debt-to-equity ratio is sky high -- but worse still, their turnover is declining.

对啊, 他们的资本负债率高得 吓人 ,不过更糟的是, 他们的营业额正在下降中.

2、Further, he did not believe banks should have to pre-fund compensation schemes and said contingent capital – debt that can turn into equity in times of stress – was too complex.

3、For the most fatally undercapitalised banks those that cannot meet the standards in any reasonable timeframe they should be subjected to forced debt-to-equity conversion.

4、That shift, however, has turned as financial companies raise equity capital to repair balance sheets, private equity deals slow to a trickle and the cost of raising corporate debt rises sharply as its availability dries up.
