

《凯莎手持大刀唱《Backstabber》疑似diss水果姐》

震惊！凯莎在Lollapalooza音乐节上放大招！

她手持大刀演唱热门单曲《Backstabber》，疑似公开diss凯蒂·佩里！歌词“Katie's to my left, rippin' my style”，配上她手中挥舞的大刀和一脸嫌弃的表情，简直让人直呼“绝了”！

粉丝们纷纷猜测，这是不是对凯蒂与卢克博士合作的另类“抗议”？毕竟，两人的恩怨情仇可不是一天两天了。

Kesha has appeared to diss Katy Perry live on stage while holding a large knife.

在舞台上，凯莎手持大刀，疑似在公开diss凯蒂·佩里。

The pop star performed at Lollapalooza 2024 and made the apparent dig while singing her hit Backstabber. Her song features the line "Katie's to my left, rippin' my style".

这位流行歌手在2024年Lollapalooza音乐节上表演时，演唱了她的热门歌曲《背叛者》，并在此过程中做出了明显的嘲讽动作。歌曲中有一句歌词是“Katie在我的左边，偷走了我的风格”。



Kesha took to the stage at the Chicago music festival wearing a white mini skirt and crop top. She held a large knife in her hand during the performance and as she sang the line, she expressed disgust on her face.

凯莎在芝加哥音乐节上身穿白色迷你裙和露脐上衣登台演出。在表演过程中，她手里拿着一把大刀，唱到这句歌词时，脸上露出了厌恶的表情。

Fans pointed out the line has taken on a new meaning recently as Kesha hasn't been quiet about Katy's recent work with Dr Luke.

粉丝们指出，这句歌词最近有了新的含义，因为凯莎对凯蒂最近与卢克博士的合作一直直言不讳。

The I Kissed A Girl hitmaker is currently trying to make a musical comeback and despite her efforts, her track Women's World has flopped amid a wave of controversy.

这位《I Kissed A Girl》的创作者目前正在努力回归乐坛，但她的歌曲《Women's World》在争议声中惨遭失败。

She collaborated with controversial producer Lukasz Gottwald "Dr. Luke" for the song

that failed to crack the Billboard Hot 100 Top 10 and peaked at number 63 in it's first complete tracking week.

她与备受争议的制作人卢卡什·戈特瓦尔德(昵称卢克博士)合作了这首歌，但这首歌未能进入Billboard Hot 100前十名，仅在其首周完整追踪中达到了第63名。



Back in late 2014, Keshia took Gottwald to court over claims of sexual assault and battery, sexual harassment, gender violence, emotional abuse, and violation of California business practices, all spanning a decade of working together.

早在2014年底，凯莎就因性侵、性骚扰、性别暴力、情感虐待以及违反加利福尼亚州商业惯例等指控将戈特瓦尔德告上法庭，这些指控横跨了他们十年的合作期。

The two settled their legal battle out of court earlier this year. While Gottwald has consistently refuted all accusations of misconduct, his association with Katy's newest tune hasn't sat well with her fanbase.

今年早些时候，双方达成了庭外和解。尽管戈特瓦尔德一直否认所有不当行为的指控，但他与凯蒂最新单曲的合作却并未赢得她的粉丝的认可。

Kesha's fans praised her for the move at Lollapalooza as one said: "I'm so glad she's saying what we're all thinking." Another added: "who knew the lyrics would play in her favor years later."

在Lollapalooza音乐节上，凯莎的这一举动得到了粉丝们的称赞，有粉丝表示：“我很高兴她说出了我们所有人的心声。”另一位粉丝补充道：“谁能想到几年后的歌词会如此有利于她。”

Following her performance, Kesha admitted she was actually holding a real butcher's knife on stage.

表演结束后，凯莎承认她实际上在舞台上拿的是一把真正的屠刀。



Posting on X, she said: "Apparently the prop knife went missing and they replaced it with a real butcher knife stolen from the kitchen and i didn ' t know. till now. so watch that again.... "

她在X上发帖说：“显然，道具刀不见了，他们就用从厨房偷来的一把真正的屠刀替

换了，而我到现在才知道。所以，再看一遍吧……”

凯莎和卢克博士的恩怨可以追溯到10年前，那时，卢克博士是凯莎的歌曲制作人。

2004年，凯莎起诉卢克博士对她进行性侵、殴打和骚扰，而卢克博士坚决否认，双方因此陷入了长达十年的法律拉锯战。



In October 2004, singer Kesha filed a lawsuit against Dr. Luke, real name Lukasz Gottwald, in a California state court where she alleged that the producer had sexually assaulted, battered, and harassed her in 2005.

2004年10月，歌手凯莎在加州州法院对卢克博士(真名卢克·戈特瓦尔德)提起诉讼，指控这位制作人在2005年对她进行性侵、殴打和骚扰。

In response, Dr. Luke sued Kesha in New York for defamation, which was scheduled for trial in July.

作为回应，卢克博士在纽约对凯莎提起了诽谤诉讼，该案原定于7月开庭审理。

But the pair have now released a joint statement as agreed to resolve a decade-long legal battle out of court ahead of its scheduled trial next month.

但如今，双方已发布联合声明，同意通过庭外和解的方式解决这场长达十年的法律纠纷。

Taking to Instagram on Thursday, both parties released a public statement, which began with: "Kesha and Dr. Luke have agreed to a resolution of the lawsuit, and have agreed to issue and post a joint statement regarding that resolution.

周四，双方均在Instagram上发布了公开声明，声明开头为：“凯莎和卢克博士已就诉讼达成和解，并同意发布并张贴一份关于该和解的联合声明。”



It was added: "In resolution of that lawsuit, Kesha and Dr. Luke each state the following," before Kesha wrote: "Only God knows what happened that night. As I have always said, I cannot recount everything that happened.

随后补充道：“在解决该诉讼的过程中，凯莎和卢克博士各自声明如下”，之后凯莎写道：“只有上帝知道那晚发生了什么。正如我一直所说，我无法细数所发生的一切。

"I am looking forward to closing the door on this chapter of my life and beginning a new

one. I wish nothing but peace to all parties in involved."

“我期待着为这段人生篇章画上句号，并开启新的篇章。我祝愿所有相关方平安无事。”

Dr. Luke wrote: "While I appreciate Kesha again acknowledging that she cannot recount what happened that night in 2005. I am absolutely certain that nothing happened.

卢克博士写道：“虽然我感谢凯莎再次承认她无法复述2005年那晚发生的事情。但我绝对肯定什么都没有发生。

"I never drugged or assaulted her and would never do that to anyone. For the sake of my family, I have vigorously fought to clear my name for nearly 10 years. It is time for me to put this difficult matter behind me and move on with my life. I wish Kesha well."

“我从未给她下药或袭击她，也永远不会对任何人做这种事。为了我的家人，我奋力抗争了近10年来澄清我的名声。现在是我把这件棘手的事情抛诸脑后，继续我的生活的时候了。我祝愿凯莎一切都好。”

Kesha and Dr. Luke have been battling it out in the courtrooms since 2014, with the latter always maintaining his innocence.

自2014年以来，凯莎和卢克博士一直在法庭上展开激烈对抗，后者始终坚称自己无辜。
