1、Today, the big four state banks in China are, essentially, insolvent.

今天, 中国四大国有银行已经基本不具备清偿能力.

2、It has the power to expel companies or dealers believed to be dishonest or insolvent.

它有权开除那些被认为不守信用或无偿付能力的公司或经纪人.

3、Their electorates will care if their government is insolvent or their countries suffer decades of slump.

如果这些国家的政府无力偿债,或者经济持续几十年萎靡不振,选民们是不会冷眼旁观的.

4、But many banks are now assumed to be not only illiquid but insolvent.

但是现在许多银行被认为不但仅是流动性差,并且是无偿付才干.

5、The company was declared insolvent.

公司被宣布无清偿能力.

6、But the question we really should be asking is: why keep insolvent banks afloat?

7、Once unsecured debtholders of insolvent banks lose, market discipline would return to the whole sector.

一旦无力偿债银行的无担保债权人真的遭受损失, 市场纪律就将重返整个行业.

8、The FSLIC, which insured depositors' money, itself became insolvent.

9、A firm never gets its money because another firm whom they supplied with goods become insolvent.

10、But more than a few toppled into bankruptcy, and some became insolvent.

11、As such it is beneficial to know about the process of insolvent liquidation of a company.

12、The court appointed a receiver to administer and liquidate the assets of an insolvent corporation.

14、Another important complication is that frequently companies that are now insolvent may have contributed significantly.

15、If returns on equity become negative in a thinly capitalised business, many banks will become insolvent.

16、Well over a third of loans were not being repaid and virtually every lender technically insolvent.

远超过三分之一的贷款未得到偿还,几乎所有银行在技术上均已处于破产状态。

17、But taking control of insolvent banks is the more urgent priority.

18、The extent laid on the house by court made the insolvent man homeless.

法院对这个破产者房产的扣押使他无家可归.
