1、abbr.General Agreement on Tariffs and Trade 关贸总协定;

1、The GATT permits countries to levy anti-dumping duties if their industries are or might be injured.

2、 With regard to security exceptions, the provisions of Article XXI of GATT 1994 apply.

9、 It developed out of the General Agreement on Tariffs and Trade or GATT.

11、 The WTO is the embodiment of the Uruguay Round results and the successor to the GATT.
